RESIDENTS TO VOTE MAY 21st ON 2024-25 BUDGET Dear District Residents.

The details of the proposed 2024-2025 school budget are included in this newsletter. The total budget of \$27,766,482 represents a decrease of 3.17% over the 2023-24 budget, equating to an overall 2.50% local tax levy increase.

The greatest challenge within this year's budget development process was the Governor's decision to arbitrarily lower one of the variables used to calculate our state aid (inflation factor reduced from 4.1 % to 2.8%) and the overall negative impact that had on what we were anticipating in our 24-25 state aid allocation. Careful long-range fiscal planning and adequately funded reserves has positioned us in the best possible solution to "weather" this loss in state aid over the next several years. Similar to your own family's budget, tighter financial times also forces you to more critically evaluate your spending and make proactive reductions where possible without compromising on those things that you hold most important: for your home it's your kids and for us as a district it is our students!

During this year's budget development process, the administrative team and Board of Education continued to base all decisions on the priorities developed during this year's strategic planning process (Moravia's Blueprint for Success) including our mission "to ensure individuals explore their passions, engage with purpose, and achieve academic excellence." To that end, this year's proposed budget includes: additional opportunities for our youngest learners including a third section of Universal Pre-Kindergarten (UPK), continued support of our award-winning Project-Based Learning in our Middle School and an expansion of our Career and Technical Education (CTE) opportunities at the High School. In addition, we stand committed to the diverse offerings in extracurricular, the arts and athletics that are second to none for a district of our size. We believe it is often these experiences and opportunities for our students that help us towards our vision to be a "world class community school that is a district of choice for all students and staff." Thank you for supporting this vision from the stands and auditorium seats in what has been a truly historic year for the Blue Devil Nation!

Along with the budget, there is a proposition to purchase three 66-passenger school buses. The purchase of these buses allows the district to continue the 8-year replacement plan that was designed to be both safe and cost-effective. Residents will also elect two members of the Board of Education.

We believe that this budget represents a balance between educational opportunities for our students as well as continued fiscal stewardship for our taxpayers. Please review the enclosed information and feel free to ask for any necessary clarification. John Birmingham, our Superintendent of Schools; Jeff Lawrence, our School Business Administrator; or any Board of Education member will be happy to answer any questions or address any concerns that you may have. The school budget presentation will be on Tuesday, May 7, 2024 at 7:00 PM in the Middle/High School Cafeteria. More importantly, the budget vote and election will be held on Tuesday, May 21, 2024 between 7:00 AM and 9:00 PM in the MSHS North Foyer.

We would like to take this opportunity to again thank you the residents of the Moravia Central School District for your continued support in helping us provide world-class opportunities for our students.

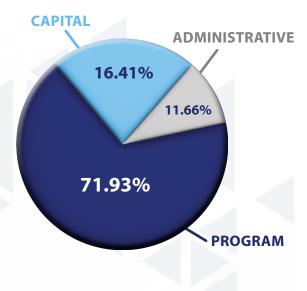

THREE-PART BUDGET



ADMINISTRATIVE

Salaries and benefits, as well as all other costs to operate the district office and each school's main office and cover Board of Education expenses.

PROGRAM

Funding for all K-12 educational programs, including teacher and support staff salaries and benefits, BOCES special education and instructional services, interscholastic athletics and transportation.

CAPITAL

Cleaning and maintaining district facilities, including salaries, benefits, service contracts, utilities, materials and supplies, capital outlay projects and debt service.

PROPOSITION 1: 2024-2025 Budget

That the amount of \$27,766,482 be approved for the 2024-2025 school year and the Board of Education of the Moravia Central School District be authorized to levy the necessary tax on real property of the district.

PROPOSITION 2: Bus Purchase

RESOLVED, that the Moravia Central School District is hereby authorized to purchase and finance student transport vehicles, including necessary furnishings, fixtures and equipment and all other costs and incidental thereto, and expend a total sum not to exceed \$418,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education Law; and in anticipation of such tax, obligations of said School District, in the principal amount not to exceed \$418,000, shall be issued.

PROPOSITION 4: *Powers Library*

RESOLVED, that pursuant to Education Law, Section 259, the Board of Education of the Moravia Central School District is authorized to levy and collect an annual tax, year after year, separate and apart from the annual school district budget, in the amount of \$1,890.00, in addition to the current appropriation of \$94,500.00 for a total of \$96,390.00 annually, which shall be paid to the Powers Library and for the support and maintenance of the library; with this appropriated amount to be the annual appropriation until thereafter modified by a future vote of the electors of the Moravia Central School District.

POWERS LIBRARY VOTE

Public Libraries within New York State have the right to place their levy proposition on the Board of Education's ballot for submission to the voters. Powers Library serves the entire community of the Moravia Central School District and can levy taxes to the community it serves. The amount levied by the library is separate and apart from the school district levy, however the funds are collected and held by the school district until the funds are submitted to the library. Libraries are only required to have a proposition on the ballot when they are increasing their annual levy. If a vote on an increase were to be defeated, the funding for the library reverts to the previous amount approved by the voters.

THREE CANDIDATES SEEK TWO SEATS ON BOARD OF EDUCATION

Moravia residents will elect two members of the Board of Education to each serve a three-year term beginning July 1, 2024, and ending June 30, 2027. Candidates names were drawn by lot and will appear on the May 21 ballot in the following order:

VOTER QUALIFICATIONS

To be eligible to vote on the school budget and election, you must be a citizen of the United States who is 18 years of age or older and a legal resident of the Moravia Central School District for at least 30 days prior to the vote.

No prior registration is required. Voter qualifications are mandated in accordance with New York State Education Law.

NOTE: Voting inspectors reserve the right to check the driver's license of any voter to verify residency.

ABSENTEE VOTER AND EARLY MAIL VOTER BALLOTS

Absentee Voter and Early Mail Voter applications are available in the District Office between the hours of 8 a.m. and 4 p.m. To be counted, all ballots must be received by 5 p.m. on the day of the election May 21, 2024.
